



Hamlet of Tulita BYLAW NUMBER 272-23 “Declaration of a Civic Holiday Bylaw”

A Bylaw of the municipal corporation of the Incorporated Hamlet of Tulita in the Northwest Territories to provide for the administrative matters in respect of borrowing money pursuant to the provisions of the *Hamlets Act*, S.N.W.T. 2003, Chapter 22, s72 – s79, and subsequent amendments thereto.

WHEREAS Council of the Incorporated Hamlet of Tulita may desire, from time to time, to declare a civic holiday in the hamlet for the purpose of events, such as the Tulita Spring Carnival; and

WHEREAS it sometimes not practical to call Council together for a Special Meeting simply to complete this declaration;

NOW, THEREFORE, the Council of the Incorporated Hamlet of Tulita at a meeting duly assembled meeting, enacts as follows:

1. This bylaw may be cited as the “Declaration of a Civic Holiday Bylaw”.
2. Council of the Incorporated Hamlet of Tulita shall authorize the Mayor or Deputy Mayor to provide for the Declaration of a Civic Holiday and sign an appropriate Proclamation Form, as attached as Appendix “A”, without a separate bylaw of Council, on the following conditions:
 - 2.1 This authority shall only be exercised up to a maximum of three (3) times per calendar year, however one of the Civic Holiday Proclamations must be reserved for the annual **Tulita Spring Carnival**, and one must be reserved for the **Tulita Fire Day**;
 - 2.2 The Declaration of a Civic Holiday shall be for a maximum of one-half (½) day, and preferably from Noon to 5:00pm;
 - 2.3 The Proclamation shall be signed, posted in the community, and forwarded a minimum of five (5) working days in advance of the Civic Holiday, to Municipal & Community Affairs to the attention of our Regional Superintendent, and Department of Human Resources to the attention of the Deputy Minister.
3. This Bylaw shall come into effect upon Third & Final Reading.

Read a First time this 11th day of April, 2023.

Read a Second time this 11th day of April, 2023.

Read a Third & Final time this 11th day of April, 2023.

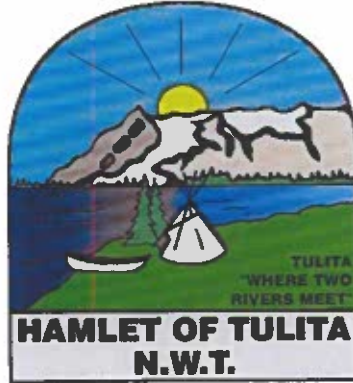




Proclamation of a Civic Holiday
